Sir,

In continuation of this Ministry's letter of even number dated 2<sup>nd</sup> January, 2018 it is informed that the Government of India has decided in consultation with the Ministry of Finance (Department of Expenditure) to revise the rate of allowances of non-teaching employees of the Central Universities (CUs) under the administrative control of MHRD on the basis of recommendations of the 7<sup>th</sup> CPC with effect from 1<sup>st</sup> July, 2017.

2. It has been decided that the rates of the allowances admissible during the 6<sup>th</sup> CPC will be revised in accordance with the provisions of the Department of Expenditure's OM No.1/1/2016-E-III(A) dated 26<sup>th</sup> July, 2017, read with Department of Expenditure's Resolution dated 06.07.2017 and the Government Orders issued from time to time in the matter for non-teaching employees of the Central Universities (CUs) under the administrative control of MHRD.

3. Since Model Code of Conduct (MCC) is in operation, the Election Commission of India (ECI) has instructed that no undue publicity in this regard may be done by anyone anywhere for attaining political mileage through it.
